Goswami Main Accused in TRP Case: Ex- BARC CEO's Counsel

Mumbai: The counsel for the former chief executive of Broadcast Audience Research Council (BARC), Partho Dasgupta, on Monday argued that Arnab Goswami of Republic TV is the main accused in the alleged Television Rating Point (TRP) manipulation case. The counsel cited the police's chargesheet.

During the hearing of Dasgupta's bail application, Sharul Singh, an advocate for Dasgupta, argued that the primary allegation against his client is a forensic audit report by a third party which claims that he turned a blind eye to the alleged TRP manipulation. Also, all other accused in the case have already been granted bail.

To this argument, Justice PD Naik, asked who is the main accused in the case. Singh replied, 'Arnab Goswami', whose WhatsApp chats with Dasgupta have been cited as evidence in the chargesheet.

Singh also argued that co-accused in the alleged scam, including the COO of BARC, who had equal ranking and power to carry out the alleged manipulation was also released by the lower court on bail, while he was denied the bail.

Last week on January 20, a Sessions Court in Mumbai had rejected Dasgupta's bail application. Prior to that, a magistrate court had also rejected his bail with the observation that he played a vital role in the alleged TRP manipulation scam. He was arrested on December 24.

The Mumbai Police in its chargesheet has stated that Republic TV, Fakt Marathi, News Nation, Maha Movie and Box Cinema have alle-

SC to Hear Objections to E-voting to Close Franklin Schemes

New Delhi: The Supreme Court said it would hear next Monday objections to e-voting by unitholders on the winding up of six Franklin Templeton schemes, before it takes a call on if and when to allow disbursement of the funds with the mutual fund schemes.

The bench said it would consider the question over regulator Securities and Exchange Board of India's powers to act in such cases at a later stage.

A three-judge bench led by Justice S Abdul Nazeer said the court would first deal with objections to e-

voting that the court recently asked the Templeton trustees to hold. Justice Sanjiv Khanna is also part of the bench.

The top court had earlier asked the trustees to conduct e-voting before a call is taken on the disbursement of funds. But a report by the observer appointed to oversee the process submitted to the court that there were many irregularities in the process, including alleged wrongdoing by K Fintech which was conducting the vote.

Many of the votes could be traced back to the K Fintech website, the observer's report has said. This has led to so-



me unitholders opposing the winding up to demand that the court first deal with this.

Templeton, represented by senior advocate Harish Salve, though dubbed the nay-sayers "as a handful of people with a litany of complaints".

He suggested that SBI Caps, and not SBI Mutual Funds, be placed in charge of any eventual distribution of funds to avoid any conflict of

interest issues.

Senior advocate Meenakshi Arora, appearing for the unitholders who have challenged the winding up, opposed any move to disburse the funds trapped in these schemes without the court first addressing their concerns over the observer's report.

She alleged that K Fintech was actually the old Karvy which had ear-

lier violated the trust of the investors and demanded a copy of Sebi's forensic audit of the schemes.

Sebi through senior advocate Arvind Datar urged the court to quickly address the return of the money with the fund estimated at ₹9,000 crore to the unitholders. "This is hard-earned money of the investors. It is lying around for distribution," he said.
