The cut-off date i.e. the record date for the purpose of E-voting is Thursday, 15<sup>th</sup> September, 2016. During the E-voting period, Members of the Company holding shares either in physical or dematerialised form, as on the record date may cast their vote electronically.

Please read the instructions printed overleaf before exercising the vote. This Communication forms an integral part of the Notice dated 10<sup>th</sup> August, 2016 convening the Annual General Meeting of the Company. A copy of the said Notice is enclosed herewith for your kind perusal.

## **INSTRUCTIONS FOR E-VOTING**

Members are requested to follow the instructions mentioned hereunder for casting their vote through E-voting:

- a) Open email and open PDF file viz: "remote e-voting.pdf" with your Client ID or Folio No. as password. The said PDF file contains your user ID and password/PIN for e-Voting. Please note that the password is an initial password.
- b) NSDL shall also be sending the User-ID and Initial password to those members whose shareholding is in dematerialized format and whose Email addresses are registered with the Company/Depository Participants. For members who have' not registered their Email Id can use the details as mentioned in the table above.
- c) Launch the internet browser by typing the following https://www.evoting.nsdl.com.
- d) Click on 'Shareholder-Login'
- e) Put User ID and Password as Initial Password/PIN noted in step (a) then Click login. If you are already registered with NSDL for E-voting then you can use your existing User ID and Password for Login.
- f) If you are logging in for the first time, Password Change Menu appears. If you desire change the Password of your choice with minimum 8 digits / characters or a combination thereof. Please preserve your new Password. It is strongly recommended not to share your Password with any other person and take utmost care to keep your Password confidential.
- g) Home page of E-voting opens. Click on 'E-voting': Active Voting Cycles.
- h) Select 'EVEN (E-Voting Event Number)' of Garware Polyester Limited.
- i) Now you are ready for 'E-voting' as 'Cast Vote' page opens.
- j) Cast your vote by selecting appropriate option and click 'Submit' and also 'Confirm' when prompted.
- K) Upon confirmation, the message "Vote cast successfully" will be displayed.
- I) Once you have voted on the resolution, you will not be allowed to modify your vote.
- m) Institutional members (i.e. members other than individuals, HUF, NRIs, etc.) are also required to send scanned copy (PDF/JPG format) of the relevant board resolution / authority letter, etc. together with the attested specimen signature(s) of the duly authorized signatory(ies) who are authorized to vote, to the Scrutinizer through email at: <a href="mailto:nilesh@ngshah.com">nilesh@ngshah.com</a> with a copy marked to <a href="mailto:evoting@nsdl.co.in">evoting@nsdl.co.in</a>.
- n) In case of any queries, you may refer the Frequently Asked Questions (FAQs) for Shareholders and E-voting user manual for Shareholders available at the 'downloads' section of <a href="https://www.evoting.nsdl.com">https://www.evoting.nsdl.com</a> or call on toll free No. 1800-222-990.
- o) The voting rights of shareholders shall be in proportion to their shares of the paid-up equity share capital of the company as on the cut-off date (record date) of 15<sup>th</sup> September, 2016.
- p) If you are already registered with NSDL for e-voting then you can use your existing user ID and password/PIN for casting your vote.
- q) You can also update your mobile number and e-mail id in the user profile details of the folio which may be used for sending future communication(s).
- r) Mr. Nilesh G. Shah, practicing Company Secretary (Membership No. FCS-4554, CP No. 2631 has been appointed as the Scrutinizer to scrutinize the E-voting process in a fair and transparent manner.
- s) The Scrutinizer shall after the conclusion of voting at AGM, first count the votes cast at the meeting and thereafter unblock the votes cast through remote e-voting in the presence of at least two witnesses not in the employment of the Company and will make, not later than 48 hours of the conclusion of AGM, a consolidated Scrutinizer's Report of the total votes cast in favour or against, if any, forthwith to the Chairman of the Company or in his absence to a person authorised by him in writing, who shall countersign the Scrutinizer's Report and shall declare the result forthwith.
- t) The Results shall be declared on or after the AGM of the Company. The Results declared along with the Scrutinizer's Report shall be placed on the Company's website <a href="www.garwarepoly.com">www.garwarepoly.com</a> and on the website of NSDL immediately after the declaration of result by the Chairman or a person authorized by him in this behalf. The results shall also be uploaded on the BSE Listing Portal.
